ORDER

On December 2, 1999, in Case No. 1999-00312, the Commission approved rates for Millennium Energy, Inc. ("Millennium") and provided for their further adjustment in accordance with Millennium's Gas Cost Adjustment clause.¹

On June 4, 2018, Millennium filed its proposed Gas Cost Recovery ("GCR") rate application to be effective July 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Millennium's notice sets out an Expected Gas Cost ("EGC") of \$3.2916 per Mcf, which is an increase of \$.1388 per Mcf from its previous EGC of \$3.1528 per Mcf.

3. Millennium's notice sets out no Refund Adjustment.

4. Millennium's notice sets out a current quarter Actual Adjustment ("AA") of (\$.0846) per Mcf. Millennium's total AA is (\$.3479) per Mcf, which is a decrease of \$.0692 per Mcf from the previous total AA of (\$.2787) per Mcf.

5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0169) per Mcf. Millennium's total BA is (\$.0057) per Mcf, which is a decrease of \$.0288 per Mcf from the previous total BA of \$.0231 per Mcf.

 Millennium's GCR rate is \$2.9380 per Mcf, which is an increase of \$.0408 per Mcf from the previous GCR rate of \$2.8972 per Mcf.

7. The rates proposed by Millennium and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after July 4, 2018. Millennium did not provide the 30 days' notice required for its rate to be effective July 1, 2018.

IT IS THEREFORE ORDERED that:

1. The rates set forth in the Appendix to this Order are approved for service rendered on and after July 4, 2018.

2. Within 20 days of the date of entry of this Order, Millennium shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

This case is closed and removed from the Commission's docket.
