ORDER

On November 5, 2013, in Case No. 2013-00150,¹ the Commission approved rates for Valley Gas, Inc. ("Valley Gas") and provided for their further adjustment on a quarterly basis in accordance with Valley Gas's Purchased Gas Cost Adjustment ("GCA") clause.

On June 4, 2018, Valley Gas filed its Gas Cost Recovery ("GCR") rate application to be effective July 1, 2018. On June 13, 2018, Valley Gas filed a supplement to its GCR application.

After reviewing the record in this case, and being otherwise sufficiently advised, the Commission finds that:

- Valley Gas's notice includes a revised rate designed to pass on to its customers its expected change in gas costs.
- 2. Valley Gas's notice sets out an Expected Gas Cost ("EGC") of \$3.5927 per Mcf. Valley Gas did not use the correct sales volumes in the calculation of its EGC. Valley Gas's corrected EGC is \$4.4631 per Mcf, which is an increase of \$.4311 per Mcf from the previous EGC of \$4.0320 per Mcf.

- Valley Gas's notice sets out no Refund Adjustment.
- 4. Valley Gas's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$1.0132 per Mcf. Valley Gas did not use the correct Actual Sales volumes for the months of January, February, and March 2018. Furthermore, because the Commission did not enter an Order approving a change in Valley Gas's PGA rates in Case No. 2017-00439,² the Third Previous Quarter ACA of (\$.0233) per Mcf was refunded to customers over 15 months instead of 12 months. This led to Valley Gas refunding \$463.18 more than it should have.³ Correcting this produces a current quarter ACA of (\$1.4058) per Mcf. Valley Gas did not use the correct Second Previous Quarter ACA of \$.0000 per Mcf, or the correct Third Previous Quarter ACA of (\$.2605) per Mcf. Correcting this produces a total ACA of (\$.4000) per Mcf, which is a decrease of \$.7470 per Mcf from its previous total ACA of \$.3470 per Mcf.
- Valley Gas's corrected GCR rate is \$4.0631 per Mcf, which is a decrease
 s \$4.3790 per Mcf.
- 6. The rate set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Valley Gas on and after July 1, 2018.

IT IS THEREFORE ORDERED that:

- The rate proposed by Valley Gas is denied.
- 2. The rate set forth in the Appendix to this Order is approved for service rendered on and after July 1, 2018. Although Valley Gas's GCR rate filing did not

provide 30 days' notice to the Commission as required by its tariff, KRS 278.180(2) authorizes the Commission to make a reduction in rates effective in less than 30 days.

3. Within 20 days of the date of entry of this Order, Valley Gas shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.

4. This case is closed and removed from the Commission's docket.
