## ORDER

On June 15, 2018, Dexter-Almo Heights Water District (Dexter-Almo Heights District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission notes that in its 2016 Annual Report, Dexter-Almo Heights District reported a water loss of 16.4455 percent.<sup>2</sup> Dexter-Almo Heights District's application provides updated purchases and sales information for a more current period than the 2016 Annual Report. Commission regulation 807 KAR 5:066(6)(3) states that for ratemaking purposes a utility's unaccounted-for water loss shall not exceed 15 percent of the total water produced and purchased, excluding water consumed by a utility in its own operations. Based upon the updated information in the application and the percentage of other water consumed by the utility in its 2016 Annual Report,<sup>3</sup> Dexter-Almo Heights

District's unaccounted-for water loss is determined to be 22.5273 percent for the updated period.<sup>4</sup>

Reduction of Dexter-Almo Heights District's unaccounted-for water loss to 15 percent would result in an approximate \$11,205<sup>5</sup> decrease to purchased water expense. Potentially, Dexter-Almo Heights District is paying \$0.32 per 1,000 gallons sold for expenses associated with unaccounted-for water loss in excess of the allowable 15 percent<sup>6</sup> threshold.

The Commission is placing greater emphasis on monitoring utilities that consistently exceed the 15 percent unaccounted-for water loss threshold and strongly encourages Dexter-Almo Heights District to pursue reasonable actions to reduce its unaccounted-for water loss. Failure by Dexter-Almo Heights District to make significant progress towards reducing unaccounted-for water loss may cause the Commission to pursue additional action with the utility.

The Commission, having reviewed the record and being sufficiently advised, finds that:

 Dexter-Almo Heights District purchases water from the Murray Municipal Utilities (Murray).

- 2. Murray notified Dexter-Almo Heights District that its wholesale rate would increase from \$2.94 per 1,000 gallons to \$3.23 per 1,000 gallons effective July 1, 2018.<sup>7</sup> Dexter-Almo Heights District proposes to increase the water rates to its customers effective July 1, 2018, to reflect the increased cost of purchased water from Murray.
- 3. Dexter-Almo Heights District proposed a purchased water adjustment factor of \$0.38 per 1,000 gallons in its application.
- 4. During the 12 months ended April 30, 2018, Dexter-Almo Heights District purchased 46,086,500 gallons of water from Murray. During the same period, Dexter-Almo Heights District sold 35,607,700 gallons of water. The increase in the cost of purchased water is \$13,365.09, resulting in a purchased water adjustment factor of \$0.38 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.38 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable, and should be approved.
  - 6. Dexter-Almo Heights District's proposed rates should be approved.
- 7. The rates as set forth in Appendix B to this Order, are fair, just, and reasonable, and should be approved for water service rendered by Dexter-Almo Heights District on and after July 1, 2018.

#### IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.38 per 1,000 gallons is approved.

- 2. The rates proposed by Dexter-Almo Heights District are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Dexter-Almo District on and after July 1, 2018.
- 4. Within 20 days of the date of entry of this Order, Dexter-Almo Heights
  District shall file with the Commission, using the Commission's electronic Tariff Filing
  System, revised tariff sheets showing the rates approved herein.
