COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION TO KENTUCKY-AMERICAN WATER COMPANY

Kentucky-American Water Company (Kentucky-American), pursuant to 807 KAR 5:001, is to file with the Commission the original with six copies of the following information. The information requested herein is due no later than ten days from the issuance of this request. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Kentucky-American shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Kentucky-American fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filling a paper containing personal information, Kentucky-American shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that the personal information cannot be read.

- Refer to the Application, Exhibit 1, Project Summary, Expected Project Cost at 4.
- a. Kentucky-American states that it is currently receiving cost estimates from vendors to perform the indicated work. Explain in detail the process Kentucky-American used to solicit bids from the vendors.
- b. Provide a schedule listing the estimated costs vendors have submitted to date, identify any bids that have been accepted, and provide copies of all supporting bid documentation.
 - 2. Refer to the Application, Item 14 at page 5.
- a. Provide a breakdown of the estimated construction costs by uniform system of accounts (USoA) account numbers.

- b. Provide the depreciation life that Kentucky-American will use for each USoA account identified in Item 2.a. Include documentation to support each depreciation life.
- 3. Refer to the Application, Item 8 at page 4. Expand on Kentucky-American's explanation of how Kentucky-American will finance the construction project.
