On July 18, 2018, the Commission entered an Order approving an application filed by Breathitt County Water District (Breathitt District) for approval of a purchased water adjustment. The Commission's Order included two appendices, designated Appendix A and Appendix B. On August 15, 2018, Breathitt District filed revised tariff sheets which applied the PWA factor to its Leak Adjustment Rate and its Wholesale Rate; however, the Order issued on July 18, 2018, did not list the Leak Adjustment Rate or the Wholesale Rates in the Appendix B.


IT IS THEREFORE ORDERED, nunc pro tunc, that:
