## ORDER

On July 3, 2018, Atmos Energy Corporation (Atmos) filed a petition, pursuant to KRS 61.878(1)(c)(1) and 807 KAR 5:001, Section 13, requesting that the Commission grant confidential protection to attachments to its quarterly Gas Cost Adjustment (GCA) filing for an indefinite period. The designated materials are GCA Exhibit C, page 2, and Exhibit D, page 5, which contain information pertaining to Atmos's projected gas prices.

As the basis for its request, Atmos asserts that the natural gas industry is a highly competitive industry and public disclosure of the designated materials will result in an unfair commercial advantage to Atmos's competitors because the competitors could use the information regarding Atmos's projected gas purchases to the competitors' advantage. Atmos states that the designated materials are the same type of information contained in prior GCA fillings and that Commission has consistently granted confidential protection to the designated materials in the past.

Having considered the petition and the designated materials, the Commission finds that the designated materials in GCA Exhibit C, page 2, and Exhibit D, page 5, are generally recognized as confidential or proprietary, and therefore meet the criteria for confidential treatment and are exempted from public disclosure pursuant to KRS 61.878(1)(c)(1) and 807 KAR 5:001, Section 13.

## IT IS THEREFORE ORDERED that:

- Atmos's petition for confidential protection for GCA Exhibit C, page 2, and Exhibit D, page 5, is granted.
- 2. The designated materials in GCA Exhibit C, page 2, and Exhibit D, page 5, shall not be placed in the public record or made available for public inspection for an indefinite period of time, or until further Orders of this Commission.
- 3. Use of the materials in question in any Commission proceeding shall comply with 807 KAR 5:001, Section 13(9).
- 4. Atmos shall inform the Commission if the materials in question become publicly available or no longer qualifies for confidential treatment.
- 5. If a non-party to this proceeding requests to inspect the materials granted confidential treatment by this Order, then Atmos shall have 20 days from receipt of written notice of the request to demonstrate that the materials still fall within the exclusions from disclosure requirements established in KRS 61.878. If Atmos is unable to make such demonstration, the designated materials shall be made available for inspection. Otherwise, the Commission shall deny the request for inspection.
- 6. The Commission shall not make the designated materials available for inspection for 20 days following an Order finding that the materials no longer qualify for confidential protection in order to allow Atmos to seek a remedy afforded by law.
