### ORDER

On July 11, 2018, Sentra Corporation (Sentra) filed an Application for an adjustment of its Gas Cost Recovery (GCR) rate. Included with the Application, Sentra filed a petition (Petition) requesting prospective correction of the base rate set forth in the Appendix to Case No. 2018-00124,¹ which inadvertently applied the GCR rate to base rates in effect prior to those approved in Case No. 2016-00384.² In compliance with the Order issued in Case No. 2018-00124, Sentra filed a tariff and billed customers using the incorrect base rates. In the Petition, Sentra stated that it does not propose to recover the under-billing for services rendered between May 1, 2018, and July 31, 2018.

On July 26, 2018, the Commission issued an Order in this matter approving the revised rates and left this case open to conduct discovery regarding the under-recovery of rates. On August 9, 2018, Sentra filed its responses to the Commission's request for information. The Commission has calculated the amount under-recovered by Sentra from May 1, 2018, through July 31, 2018, due to the error in the final Order in Case No. 2018-00124, and has determined that amount to be \$3,308.06. Given the small amount of the

under-recovery, the Commission finds that Sentra should include this amount for recovery in its next GCR application for rates effective November 1, 2018. Sentra should include the amount as a separate line item on the actual adjustment schedule and should add the amount to any actual adjustment calculated in that case. Furthermore, when Sentra files its next GCR application, the cover letter of that application should reference this Order and state that the amount has been included for recovery pursuant to this Order.

#### IT IS THEREFORE ORDERED that:

- 1. Sentra shall include the \$3,308.06 under-recovery in the actual adjustment component of its next GCR application for rates effective November 1, 2018.
  - 2. This case is closed and removed from the Commission's docket.
