ORDER

On August 29, 2018, Western Lewis-Rectorville Water and Gas District (Western Lewis District) filed its proposed Gas Cost Recovery (GCR) rate to be effective October 1, 2018. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Western Lewis District's application includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Western Lewis District's application sets out an Expected Gas Cost (EGC) of \$4.0802 per Mcf. Due to a spreadsheet rounding error, Western Lewis District erroneously set out an incorrect EGC rate. Western Lewis District's corrected EGC rate is \$4.0801 per Mcf.
- Western Lewis District's application sets out a Refund Adjustment (RA) of (\$1.2500) per Mcf.
- 4. Western Lewis District's application sets out a current quarter Actual Adjustment (AA) of (\$.3844) per Mcf and a total AA of (\$.8444) per Mcf.
- 5. Western Lewis District's application sets out no current quarter Balance Adjustment (BA) and no total BA.

- 6. Western Lewis District's corrected GCR rate is \$1.9857 per Mcf, which is a decrease of \$.3600 per Mcf from the previous GCR rate of \$1.6257 per Mcf.
- 7. The rates as set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Western Lewis District on and after October 1, 2018.

IT IS THEREFORE ORDERED that:

- 1. The rate proposed by Western Lewis District is denied.
- 2. The rates set forth in the Appendix to this Order are approved for service rendered by Western Lewis District on and after October 1, 2018.
- 3. Within 20 days of the date of entry of this Order, Western Lewis District shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 4. This case is closed and removed from the Commission's docket.
