ORDER

On November 27, 2018, Natural Energy Utility Corporation (Natural Energy) filed its Gas Cost Recovery (GCR) rate application to become effective January 1, 2019. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Natural Energy's application includes revised rates designed to pass on to its customers its expected change in gas costs.
- Natural Energy's application sets out an Expected Gas Cost (EGC) of \$3.7125 per Mcf.
 - 3. Natural Energy's application sets out no Refund Adjustment.
- Natural Energy's application sets out a current quarter Actual Adjustment
 (AA) of (\$.0326) per Mcf and a total AA of (\$.6415) per Mcf.
- Natural Energy's GCR is \$3.0710 per Mcf, which is an increase of \$.3112
 per Mcf from its previous GCR of \$2.7598 per Mcf.
- 6. The rates as proposed by Natural Energy and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Natural Energy on and after January 1, 2019.

IT IS THEREFORE ORDERED that:

- The rates proposed by Natural Energy and set forth in the Appendix to this
 Order are approved for final meter readings on and after January 1, 2019.
- 2. Within 20 days of the date of entry of this Order, Natural Energy shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - This case is closed and removed from the Commission's docket.
