ORDER

On November 27, 2018, Burkesville Gas Company, Inc. (Burkesville), filed its Gas Cost Recovery (GCR) rate application with a proposed effective date of December 28, 2018.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville's application includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Burkesville's application sets out an Expected Gas Cost (EGC) of \$9.0844 per Mcf.
3. Burkesville's application sets out no Refund Adjustment.
4. Burkesville's application sets out a current quarter Actual Cost Adjustment (ACA) of (\$.0066) per Mcf and a total ACA of (\$.2319) per Mcf.
5. Burkesville's GCR rate is \$8.8525 per Mcf, which is an increase of \$1.1477 per Mcf from the previous GCR rate of \$7.7048 per Mcf.

6. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after December 28, 2018.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Burkesville and set forth in the Appendix to this Order are approved for service rendered by Burkesville on and after December 28, 2018.

2. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
