REQUEST FOR INFORMATION TO NON-PARTY EVANS HARDWARE, INC.

Regarding all debt owed to Evans Hardware, Inc. by Martin County Water District (Martin District):

1. Provide the date when Martin District first began to accrue past-due debt to Evans Hardware.
2. Beginning on the date when Martin District first began to accrue past-due debt to Evans Hardware, provide the monthly totals for amounts purchased and the past due outstanding debt balance that was carried forward. If interest was charged, provide separate monthly totals for the items purchased and the total amount of interest charged for each month.
3. Beginning on the date when Martin District first began to accrue past-due debt to Evans Hardware, provide the interest rate for each month that Evans Hardware charged interest on Martin District's past-due debt.
4. State whether Evans Hardware charges simple or compound interest on Martin District's past-due debt.
5. Provide a copy of any contracts or agreements between Martin District and Evans Hardware related to any past-due debt accrued by Martin District for purchases from Evans Hardware.
