ORDER

On October 3, 2018, counsel for Kentucky Utilities Company (KU) and Louisville Gas and Electric Company (LG&E) (jointly, "KU/LG&E") sent an electronic mail message to Commission Staff Counsel regarding two errors contained in Appendix H to the Commission's rehearing Order entered on September 28, 2018. A copy of that electronic mail message is attached hereto. Both errors relate to the Tax Cuts and Jobs Act (TCJA) Surcredit gas rates set forth in Appendix H. The first error is that the TCJA Surcredit gas rates are referred to as "per kWh" rather than "per ccf," and the second error is that the residential electric rate classes are listed as being residential gas rate classes.

Based on the KU/LG&E electronic mail message and finding good cause, the Commission HEREBY ORDERS NUNC PRO TUNC that:

- 1. Appendix H to the September 28, 2018 Order is amended to the limited extent that the reference to the gas TCJA Surcredit "per kWh" is deleted and replaced with "per ccf," and the listing of residential gas rate classes is deleted and replaced with "Residential (RGS, VFD)."
- All other provisions of the September 28, 2018 Order shall remain in full force and effect.

Dear Staff Counsel,

I am writing to request the Commission issue an order nunc pro tunc making a few technical corrections to the September 28, 2018 Order.

Appendix H to the September 28, 2018 Order displays the Gas Service Rates prescribed by the September 28, 2018 Order, but uses "per kWh" terminology to modify the description of the TCJA surcredit for gas customers, rather than "per Ccf" terminology. In addition, the reference to the rate schedules should reflect LG&E's gas rate schedules, rather than the electric ones.

As a result, LG&E believes the Gas Service Rates section of Appendix H should be corrected to read as follows:

GAS SERVICE RATES

RATE TCJA TAX CUTS AND JOBS ACT SURCREDIT

TCJA Surcredit per Ccf:

Effective April 1, 2018 - April 30, 2019

Residential (RGS, VFD) \$0.04775 Nonresidential (all other Rate Schedules) \$0.01977

Effective May 1, 2019

Residential (RGS, VFD) \$0.03880 Nonresidential (all other Rate Schedules) \$0.01606
