MOTION BY SOUTH KENTUCKY RURAL ELECTRIC COOPERATIVE CORPORATION TO DEVIATE FROM 807 KAR 5:001 § 8 IN REQUESTING ELECTRONIC FILING PROCEDURES AFTER CASE INITIATION

Pursuant to 807 KAR 5:001 § 22, the Applicant, South Kentucky Rural Electric Cooperative Corporation ("South Kentucky"), respectfully requests that the Kentucky Public Service Commission ("Commission") permit deviation from its rule, 807 KAR 5:001 §8(2), that a Notice of Election of Use of Electronic Filing Procedures be filed at least seven (7) days prior to submission of an application to initiate a proceeding and enter an order or otherwise direct that the procedures established in Section 8 be used in lieu of other procedures established in 807 KAR 5:001. There is good cause to support the requested deviation and the use of electronic filing procedures, as follows:

- 1. South Kentucky filed its application herein on January 31, 2018 which was assigned case no. 2018-00050. South Kentucky did not present a Notice of Election of Use of Electronic Filing Procedures either prior to or concurrent with submission of its application.
- 2. After filing its application, most, if not all, of the other rural electric cooperative corporations in the Commonwealth have intervened in this matter along with the Attorney General and Nucor Steel intervening in this matter. The individual parties involved in this

case total approximately 20 entities. The level of intervention and corresponding discovery has exceeded expectations. The intervenors combined data requests exceeded hundreds of data requests on their first deadline for data requests and many more are expected in their supplemental requests.

- 3. The number of entities in this matter and the level and amount of discovery are changes from the situation at the time the application was filed and provide good cause for allowing a post initiation request for use of electronic filing procedures. It would be more efficient and useful to use the electronic filing procedures established in 807 KAR 5:001 § 8 rather than continuing with paper filing given the voluminous nature of discovery and the number of parties.
- 4. Attached hereto South Kentucky submits a signed Notice of Election of Use of Electronic Filing Procedures.
- 5. After the recent change in counsel for South Kentucky, undersigned counsel has also reached out to intervenor counsel with regard to the above motion and the Attorney General is supportive of South Kentucky's request for modify this case to electronic filing, no other party has expressed an opinion about this motion.

Wherefore, South Kentucky respectfully requests a deviation from 807 KAR 5:001 § 8(2) for good cause shown and that the Commission enter an Order or other direct that the procedure established in § 8 be used in lieu of other procedures established in 807 KAR 5:001.
