ORDER

On February 27, 2018, Delta Natural Gas Company, Inc. ("Delta") filed an application to revise its Pipeline Replacement Program ("PRP") rates beginning May 1, 2018. The Commission issued its March 6, 2018 Order finding that further proceedings were necessary to determine the reasonableness of the proposed tariff, and therefore suspended the implementation of the PRP rate up to and including September 30, 2018. In order to facilitate the review, the Commission issued the May 10, 2018 Order setting a procedural schedule. Having discovered an error in the Commission's May 10, 2018 Order, the Commission, on its own motion, finds that the Appendix inadvertently did not include the date for Delta to file responses to any supplemental requests for information.

IT IS THEREFORE ORDERED, *nunc pro tunc*, that:

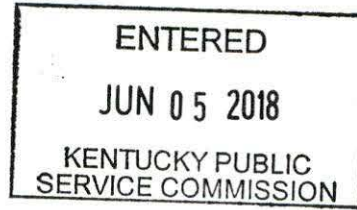
1. The Appendix of the Commission's May 10, 2018 Order is amended to read:

Delta shall file responses to supplemental requests for information no later than 07/02/18.

A request for a formal hearing or statement that this case may be submitted based on the existing record shall be filed no later than 07/09/18.

2. All other provisions of the Commission's May 10, 2018 Order not in conflict with this Order shall remain in full force and effect.
