MOTION TO SUBMIT CASE FOR ADJUDICATION ON THE ADMINISTRATIVE RECORD OR, ALTERNATIVELY, TO SCHEDULE A HEARING

Comes now Inter-County Energy Cooperative Corporation ("Inter-County"), by counsel, and, hereby moves the Kentucky Public Service Commission ("Commission") to submit the case for a decision based upon the existing record and without the need for a hearing, or in the alternative, to schedule a hearing, respectfully stating as follows:

On June 13, 2018 the Commission issued an Order establishing a procedural schedule in this case which allowed for the filing of direct testimony, data requests and a deadline for motions to intervene in the case. Inter-County subsequently filed a Motion for Deviation pertaining to customer notice. The Commission issued an Order on August 28, 2018 granting the deviation in part and extending the deadline for motions to intervene until September 7, 2018. Inter-County has provided all of the requested information through three rounds of data requests and there have been no motions for intervention filed in this case.

Since the remainder of the procedural schedule only applies to intervenors, and there are no intervenors in this case, Inter-County believes the administrative record is complete and it would be appropriate for the Commission to make a ruling based upon the record. Inter-County respectfully requests a decision from the Commission based upon the existing record. However, if the Commission believes a hearing is necessary in this matter, Inter-County requests that an Order establishing the hearing date be issued as soon as possible.

WHEREFORE, Inter-County moves the Commission to submit the case on the existing administrative record or, in the alternative, Inter-County moves the Commission to issue an order establishing a hearing date as soon as possible.
