# BIG RIVERS ELECTRIC CORPORATION'S MOTION TO HOLD REMAINING PROCEDURAL DEADLINES IN ABEYANCE AND FOR A STATUS CONFERENCE

Comes Big Rivers Electric Corporation ("Big Rivers"), by counsel, and respectfully moves the Kentucky Public Service Commission ("Commission") for an order holding the remaining procedural deadlines in abeyance and scheduling a status conference with the Commission. In support of this motion, Big Rivers states as follows:

At the oral argument held on July 26, 2018, in the above-referenced matter, the Commission indicated that it would issue a final order on part of Big Rivers' application while continuing the proceedings with respect to Big Rivers' request for authority to establish a regulatory account. Big Rivers and Kentucky Industrial Utility Customers, Inc. ("KIUC") have reached a tentative agreement to settle the remaining issues in this proceeding relating to Big Rivers' request for authority to establish a regulatory account, and Big Rivers is in discussions with the Office of the Attorney General in an effort to be in a position to submit a unanimous proposed settlement to the Commission. Big Rivers believes that suspending the

- 1 remaining procedural steps while the parties attempt to finalize a settlement
- 2 agreement will facilitate the parties reaching an agreement, will save the parties
- 3 and the Commission time and/or costs, and will lead to a reasonable resolution of
- 4 the remaining issues.
- 5 Big Rivers also requests that the Commission hold a status conference with
- 6 the parties on the record to discuss the settlement of the remaining issues and
- 7 future procedural steps.
- 8 WHEREFORE, Big Rivers respectfully requests that the Commission enter
- 9 an order holding all remaining procedural deadlines in abeyance pending
- 10 finalization and submission of a settlement agreement, and scheduling a status
- 11 conference.
