COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO HARDIN COUNTY WATER DISTRICT NO. 1

Hardin County Water District No. 1 (Hardin County District No. 1), pursuant to 807 KAR 5:001, is to file with the Commission the original with six copies of the following information. The information requested herein is due no later than ten days from the issuance of this request. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Hardin County District No. 1 shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Hardin County District No. 1 fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to respond completely and precisely.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Hardin County District No. 1 shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that the personal information cannot be read.

1. State how often Hardin County District No. 1 is currently inspecting its mechanical equipment.
2. State whether Hardin County District No. 1 has ever inspected its mechanical equipment on a daily basis, as required by regulation.
3. Refer to the Application, paragraph 3.
 - a. State whether the 13 lift stations equipped with SCADA include the three lift stations in the Fort Knox system, which are currently checked daily.
 - b. State whether the 14 lift stations include the six lift stations in the Radcliffe system, which are currently checked daily.
4. State whether the 34 lift stations equipped with SCADA will include the 6 lift stations in the Radcliffe system that are currently checked daily, and whether these 34 lift

stations include any of the 14 lift stations, which are equipped with a cellular based monitoring system capable of making alarm notifications automatically.
