MOTION TO WITHDRAW RATE INCREASE

The City of Dawson Springs and Dawson Springs City Water & Sewer (“Dawson Springs”), by counsel, respectfully moves the Public Service Commission (“Commission”) for permission to withdraw its proposed wholesale rate increase. In support of the motion, Dawson Springs states as follows:

1. On May 15, 2018, Dawson Springs filed with the Commission a revised tariff sheet setting forth proposed adjustments to its existing rates for wholesale water service to South Hopkins Water District (“South Hopkins District”) to be effective on June 26, 2018. On June 15, 2018, the Commission entered an order establishing this case, finding that an investigation was necessary to determine the reasonableness of the proposed rates. The Commission issued a procedural schedule and requests for information to Dawson Springs on September 19, 2018.

2. Dawson Springs has been negotiating a new wholesale water purchase agreement with South Hopkins District during the past few months. When this

new agreement is finalized, it will contain a wholesale rate mutually agreed upon by both Dawson Springs and South Hopkins District. Accordingly, to conserve the Commission's limited time and resources, Dawson Springs respectfully requests that the proposed wholesale rate be withdrawn at this time and the matter be closed and removed from the Commission's docket without prejudice.

WHEREFORE, Dawson Springs respectfully moves the Commission to approve the withdrawal of its proposed wholesale rate and remove the case from its docket without prejudice.


