Persons who wish to become a party to a case before the Commission may file a motion requesting to intervene. The process is spelled out in a Commission regulation, 807 KAR 5:001, Section 4(11), which is available at: <a href="http://www.lrc.ky.gov/kar/807/005/001.pdf">http://www.lrc.ky.gov/kar/807/005/001.pdf</a>. In brief, the motion must include the person's full name, mailing address, and electronic mail (email) address. The motion must state the person's interest in the case and how intervention is likely to present issues or develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission has not yet established a procedural schedule for this case, but will do so soon. The procedural schedule will include a deadline for requesting to intervene. If a person requests to intervene **after** the deadline, the motion must also set forth good cause for the delay.

Finally, the Attorney General has statutory authority to intervene in Commission matters to represent the interests of consumers under KRS 367.150(8). The public may contact the Attorney General to request him to intervene. The address for the Attorney General's Office of Rate Intervention is 700 Capitol Avenue, Suite 20, Frankfort KY 40601.
