Informal Conference of October 31, 2018

Pursuant to Commission Staff's Notice of Informal Conference issued on October, 29, 2018, a telephonic informal conference was held in this matter on October 31, 2018. Representatives of Water Service Corporation of Kentucky (Water Service Kentucky), including counsel for Water Service Kentucky, and Attorney General participated in the telephonic conference with Commission Staff (Staff). A copy of the attendance roster is attached.

Commission Staff Attorney Brittany Koenig began the conference by acknowledging the telephonic conference was requested by Water Service Kentucky to discuss witness requirements for the November 7, 2018 hearing. Ms. Koenig advised that the Commission excused Water Service Kentucky expert, John Guastella, from appearing at the November 7, 2018 hearing. Staff will direct questions regarding tax and depreciation to Steven Lubertozzi and if he is unable to answer or refers questions to Mr. Guastella, Staff will follow-up with Post-Hearing Data Requests to Mr. Guastella.

Counsel for Water Service Kentucky inquired generally about the topics Staff had questions about. Staff's response included; tax, depreciation, fire hydrants/costs associated with Ambleside, LLC and capital projects outside the test year. We also had some questions related to the cost of service study. Generally, Staff explained the submitted excel sheets were difficult to read and Mr. Lubertozzi offered to have a conference with Robert Guttormsen prior to the hearing if needed.

Finally, Staff requested counsel for Water Service Kentucky submit a complete set of invoices for legal expenses and indicate why certain bills were redacted.

Ms. Koenig advised representatives of Water Service Kentucky that Staff would prepare and enter into the record a memorandum regarding the conference. Ms. Koenig further advised that the parties would have five days after the memorandum is entered into the record to file comments on the memorandum.
