

**RESOURCES, AND REQUEST FOR EXPEDITED TREATMENT** East Kentucky Network, LLC d/b/a Appalachian Wireless ("EKN"), pursuant to 47 C.F.R.

§ 52.15(g)(4) and (5), hereby petitions the Kentucky Public Service Commission (the "Commission") to review and overturn a recent decision by the Pooling Administrator (the "PA") to withhold certain numbering resources from EKN, which are required to provision prepaid wireless services. In support of its Petition, EKN states as follows:

1. EKN is a commercial mobile radio service ("CMRS") provider and provides, among other things, prepaid wireless telecommunications services to customers in various portions of Kentucky, including the Allen rate center.

2. On June 21, 2018, EKN filed a request with the PA for a single thousands-block of numbers in the Allen rate center in conjunction with its provision of prepaid wireless telecommunications services. A copy of the Application is **attached** hereto and made a part herein is **Exhibit A**.

3. The reason for EKN's request for a single thousands-block of numbers in the Allen rate center is for provisioning of prepaid wireless services. EKN has nearly exhausted the existing thousands-blocks that are utilized by EKN for prepaid wireless customers and needs a new block

separate from its available pool of other numbers because calls to and from prepaid customers are routed in EKN's switch in a manner that is different from the routing of other accounts. More specifically, calls associated with prepaid services must be routed to a system that verifies that the prepaid customer has remaining minutes.

4. On June 21, 2018, the PA denied EKN's request on the grounds that EKN did not satisfy the months-to-exhaust ("MTE") and/or utilization requirements and also included the notice of right to proceed with filing a waiver request with the Commission. A copy of the PA's Response is **attached** hereto and made a part herein as **Exhibit B**.

5. Without the waiver, EKN will not have adequate numbering resources to provide numbering to prepaid customers from a segregated thousands-block, as is necessary for technical reasons from a network operations standpoint. Thus, EKN has demonstrated a verifiable need for the requested numbering resources and has exhausted all other available remedies.

6. Under federal numbering rules, the Commission may overturn the PA's decision based on a determination "that the carrier has demonstrated a verifiable need for numbering resources and has exhausted all other available remedies."

WHEREFORE, having made the requisite showing of verifiable need and exhaustion of other available remedies under 47 C.F.R. § 52.15(g)(4) and (5), EKN requests that the Commission:

- Reverse the PA's decision to deny EKN's request for additional numbering resources;
- B. Direct NANPA and/or PA (to the extent it is within the respective authority and responsibility of NANPA and/or PA to do so) to assign EKN one thousands-block of numbers in the Allen rate center;

C. Grant the requested relief on an expedited basis, within ten (10) days or as soon thereafter as reasonably practical; and

D. Grant such other and further relief as the Commission deems just and proper.

#### Instructions for filling out each Section of the Part 1A form:

Section 1.1 Contact information requires that Service Providers supply under "Block Applicant" the company name, company headquarters address, a contact within the company, an address where the contact person may be reached, in addition to the correct phone, fax, and e-mail address. The Pooling Administrator section also requires the Service Provider to fill in the Pooling Administrator's name, address, phone, fax

#### and e-mail.

Section 1.2 Service Providers who need a thousands-block assignment or for an Location Routing Number (LRN) are required to fill in this section. If needed for an LRN, a CO Code Application needs to also be submitted to the PA. The Service Provider should supply the Numbering Plan Area (NPA); the Local Access Transport Area (LATA), which is a three-digit number that can be found in the Telcordia Technologies, Inc. dba iconectiv (iconectiv<sup>TM</sup>) LERG<sup>TM</sup> Routing Guide<sup>xi</sup>. The Operating Company Number (OCN) assigned to the service provider and the OCN of its parent company. An OCN is a four-character alphanumeric NECA-assigned Company Code or a four-character alphanumeric identifier assigned by the iconectiv<sup>TM</sup> Telecom Routing Administration (TRA). In addition, the number of thousands-blocks requested should be supplied. The Switch Identification. Explanations of these terms may be found in the footnotes.

Section 1.3 The date the Service Provider completes the application should be entered in this section, as well as the Effective Date of the requested thousands-block.

Section 1.4 Service Providers should indicate their type, e.g., local exchange carrier, competitive local exchange carrier, interexchange carrier, CMRS or VoIP. If the block being returned is over 10% contaminated, the PA shall seek a new block holder. If question c and/or d have a response of No, the request for return shall be denied.
