Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively "the Companies") submit this response to the Attorney General's ("AG") Motion to File Comments and Comments. For their Response, the Companies state:


1. The Companies do not object to the AG's Motion to File Comments.
2. If permitted to use hyperlinks to various forms, reports and other documents that currently reside on federal or state government computer servers in lieu of providing a paper or electronic copy of such documents, the Companies' counsel agrees to provide hyperlinks to archived access or an archived service.
3. The AG misunderstands the relief that the Companies request in Paragraph 25 of their Application. They do not request relief from the obligation to provide on a physical electronic storage media a copy of any confidential Excel spreadsheet. They seek relief only from the obligation to provide the Commission on physical electronic storage media any Excel spreadsheet that has been uploaded to the Commission's server through Commission's Electronic Filing System and is available to the public for download through the Commission's website. The Companies will continue to provide in response to any lawful Order or request for

information any confidential Excel spreadsheets on physical electronic storage media to the Commission and any party who has signed a confidentiality agreement.

WHEREFORE, Kentucky Utilities Company and Louisville Gas and Electric Company respectfully request the Commission enter an order no later than August 31, 2018 granting the relief requested in their Application.
