COMMISSION STAFF'S FIRST REQUEST FOR INFORMATION
TO STEPHEN W. PEYTON

Stephen W. Peyton (Mr. Peyton), pursuant to 807 KAR 5:001, shall file with the Commission an original and three copies in paper medium of the following information, with a copy to all parties of record. The information requested is due within 20 days of the date of this request. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Each response shall include the name of the individual responsible for responding to questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Mr. Peyton shall make timely amendment to any prior response if he obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Mr. Peyton fails or refuses to furnish all or part of the requested information, he shall provide a written explanation of the specific grounds for his failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Mr. Peyton shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide the dates during which your rental property at 3111 Glenridge Drive, Lexington, Kentucky, was leased to Jennifer and Roger Owens.

2. Refer to your Complaint, unnumbered page 4, which states that you mailed a check to Kentucky Utilities Company (KU) for the monies "owed on the rental billing." Confirm that you paid KU \$213.71 for electric usage at 3111 Glenridge Drive, Lexington, Kentucky, for the period between May 30, 2018 and July 5, 2018, and the \$90 unauthorized reconnection fee that KU alleged that you owed.

3. Refer to your Complaint, the unnumbered exhibit with "Page 2" printed in the upper left corner and a handwritten note that references the exhibit is the "2nd Billing Back." Provide a copy of this bill with all pages of the bill.

4. Refer to the Commission's letter dated August 16, 2018, that acknowledged the receipt of your Complaint. In the third paragraph, you were asked to provide your email address to ensure service of Commission orders. Provide your email address or indicate that you do not have an email address.
