### **NOTICE**

P.R. Wastewater Management, Inc. (PR Wastewater) has filed an application with the Public Service Commission proposing to increase its monthly sewer rate from \$26.30 to \$35.00, an increase of 33%. PR Wastewater believes it could justify an even larger increase based on both its current operating costs and the need for additional maintenance, repairs, and replacements, but is proposing the \$35.00 rate to lessen the effects on its customers. Please be aware that PR Wastewater's rates have not been increased since the year 2000 and that its costs have increased significantly because of more stringent regulatory requirements and inflation. The proposed effective date of the change is November 6, 2018.
