ORDER

On November 30, 2018, Millennium Energy, Inc. (Millennium), filed its proposed Gas Cost Recovery (GCR) rate application to be effective January 1, 2019. In the cover letter to its application Millennium stated that it had made changes to the reporting period used in the calculation of its GCR rate in order to follow the reporting period dates as set out in Millennium's tariff on file with the Commission. Millennium used a reporting period ending September 30, 2018. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's application includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium's application sets out an Expected Gas Cost (EGC) of \$4.5053 per Mcf.
3. Millennium's application sets out no supplier Refund Adjustment.
4. Millennium's application sets out a current quarter Actual Adjustment (AA) of (\$.0125) per Mcf and a total AA of (\$.2171) per Mcf. Millennium calculated its current quarter AA using the months of August and September 2018. The month of July 2018 was not included in the calculation as the actual gas cost for that month has been trued up in Millennium's prior GCR rate application. Future GCR rate applications will return to using previous quarters in its current quarter AA calculations.

5. Millennium's application sets out a current quarter Balance Adjustment (BA) of \$.0038 per Mcf and a total BA of (\$.0158) per Mcf.

6. Millennium's GCR rate is \$4.2724 per Mcf, which is an increase of \$1.0663 per Mcf from the previous GCR rate of \$3.2061 per Mcf.

7. The rates proposed by Millennium and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after January 1, 2019.

IT IS THEREFORE ORDERED that:

1. The rates set forth in the Appendix to this Order are approved for service rendered on and after January 1, 2019.


