ORDER

On December 26, 2018, Atmos Energy Corporation (Atmos) filed its Gas Cost Adjustment (GCA) to be effective February 1, 2019.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Atmos's application includes revised rates designed to pass on to its sales customers its expected change in wholesale gas costs.
- Atmos's Expected Gas Cost (EGC) for firm sales customers is \$4.9057 per
 Mcf. Atmos's EGC for interruptible sales customers is \$3.6405 per Mcf.
 - 3. Atmos's application sets out no Refund Factor.
 - 4. Atmos's application sets out a Correction Factor (CF) of \$.0306 per Mcf.
- Atmos's application sets out a Performance-Based Rate Recovery Factor
 (PBRRF) of \$.2238 per Mcf.
- 6. Atmos's GCAs are \$5.1601 per Mcf for firm sales customers and \$3.8949 per Mcf for interruptible sales customers. The impact on firm sales customers is a decrease of \$.1016 per Mcf from the previous GCA of \$5.2617 per Mcf. The impact on interruptible sales customers is a decrease of \$.0588 per Mcf from the previous GCA of \$3.9537 per Mcf.

7. The rates proposed by Atmos and set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Atmos on and after February 1, 2019.

IT IS THEREFORE ORDERED that:

- 1. The rates set forth in the Appendix to this Order are approved for final meter readings on and after February 1, 2019.
- 2. Within 20 days of the date of the entry of this Order, Atmos shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
 - 3. This case is closed and removed from the Commission's docket.
