ORDER

Kentucky-American Water Company (Kentucky-American) is hereby notified that it has been named as a defendant in a formal complaint (Complaint) filed on January 4, 2019, a copy of which is attached hereto. The Complaint, filed by William Ellis Bollinger III (Mr. Bollinger) states that Kentucky-American has overcharged him for water that he did not use. Mr. Bollinger further asserts that after Kentucky-American replaced the meter, his water usage "went down to a normal usage." In order to determine whether the Complaint stated a prima facie case, the Commission issued an Order on February 19, 2019, requiring Mr. Bollinger to submit copies of all water bills issued to Mr. Bollinger by Kentucky-American that support the allegations made in the Complaint. On March 4, 2019, Mr. Bollinger filed his water bills from Kentucky-American into the record.
