ORDER

On June 17, 2019, Montgomery County Water District #1 (Montgomery District #1) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹ The application was rejected for failing to provide a schedule listing current and proposed rates as required by 807 KAR 5:068, Section 1(b). Montgomery District #1 was given an opportunity to correct the deficiency on or before July 1, 2019. Montgomery District #1 corrected the deficiency on June 26, 2019, and its application was accepted as filed on that date.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Montgomery District #1 purchases water from the Mount Sterling Water &
 Sewer System (Mount Sterling Water).
- 2. Mount Sterling Water notified Montgomery District #1 that its wholesale volumetric water rate to Montgomery District #1 will increase from \$3.11 per 1,000 gallons to \$3.17 per 1,000 gallons effective July 1, 2019.² Montgomery District #1 proposes to

increase the water rates to its customers effective July 1, 2019, to reflect the increased cost of purchased water from Mount Sterling Water.

- 3. Montgomery District #1 proposed a purchased water adjustment factor of \$0.07 per 1,000 gallons in its application.
- 4. During the 12 months ended April 30, 2019, Montgomery District #1 purchased 39,321,291 gallons of water from Mount Sterling Water. During the same period, Montgomery District #1 sold 33,612,430 gallons of water. The increase in the cost of purchased water is \$2,359.28, resulting in a purchased water adjustment factor of \$0.07 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.07 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable, and should be approved.
 - 6. Montgomery District #1's proposed rates should be approved.
- 7. The rates as set forth in Appendix B to this Order, are fair, just, and reasonable, and should be approved for water service rendered by Montgomery District #1 on and after July 1, 2019.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.07 per 1,000 gallons is approved.
 - The rates proposed by Montgomery District #1 are approved.
- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Montgomery District #1 on and after July 1, 2019.

4. Within 20 days of the date of entry of this Order, Montgomery District #1 shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.

5. Within 30 days of the date of entry of this Order, Montgomery District #1 shall file with the Commission Proof of Notice pursuant to 807 KAR 5:068, Section 5(3).

 Any document filed pursuant to ordering paragraph 5 of this Order shall reference the number of this case and shall be retained in the post case correspondence file.

7. This case is closed and removed from the Commission's docket.
