ORDER

By orders dated September 9, 10, and 11, 2019, the Commission scheduled separate hearings in the above cases for November 8, 2019, at its offices located at 211 Sower Boulevard, Frankfort, Kentucky. It has come to the attention of the Commission after a review of the files that there may be common issues of fact or law applicable to some or all of the cases, which might make consolidation of some or all of the cases for purposes of the hearing only appropriate.

IT IS THEREFORE ORDERED that:

1. A formal conference on the record shall be held on Thursday, October 31, 2019, at 1 p.m. Eastern Daylight Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

2. Counsel shall be prepared to discuss all common issues of fact or law that might make consolidation of some or all of the cases advantageous and in the interest of administrative economy.


