# ALLEGED VIOLATION OF UNDERGROUND FACILITY DAMAGE PREVENTION ACT

## ORDER

This matter is before the Commission upon a motion filed by Kentucky Frontier Gas, LLC (Kentucky Frontier), requesting a deviation from the filing requirements of 807 KAR 5:001, Section 7(1) in filing its response to question 1(c) of Staff's initial Request for Information. Kentucky Frontier notes that the relevant regulation requires it to file the original and ten copies in paper medium, and that the size and number of pages of the maps involved is voluminous.

Kentucky Frontier requests to file the required original in paper medium and furnish the remailing ten copies in electronic format in response to question 1(c) of Staff's Initial Request for Information.

Having reviewed Kentucky Frontier's motion and being otherwise sufficiently advised, the Commission finds that Kentucky Frontier has established good cause to permit a deviation from the filing requirements of 807 KAR 5:001, Section 7(1). When filing maps in response to Staff's initial and any subsequent requests for information in this case or Case Nos. 2019-00309, 2019-00314, 2019-00315, 2019-00316, 2019-00317, 2019-00218, 2019-00319, 2019-00320, 2019-00321, 2019-00322, 2019-00323, and

2019-00324 (collectively, with this case, referred to as Damage Prevention Cases), Kentucky Frontier shall file one original in paper medium and file the remaining ten copies in electronic format. The Commission further finds that the motion should be approved.

IT IS THEREFORE ORDERED that:

1. Kentucky Frontier's motion is granted.

2. When filing maps in Damage Prevention cases, Kentucky Frontier shall file one original copy in paper medium and ten copies in electronic medium.
