#### ORDER

On October 8, 2019, the Commission ordered Basham Construction and Rental Company, Inc. (Basham), to appear at a hearing on November 22, 2019, at 9 a.m. Eastern Standard Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, if Basham intended to present a defense in this matter.

On October 24, 2019, the Commission received a \$4,000 check for payment of Incident No. 31394. A copy of the receipt for that payment is attached to this Order as an Appendix.

The Commission finds that Basham has addressed to its satisfaction the probable violation cited by Staff in the Incident Report attached as an Appendix to its August 27, 2019 Order. The Commission further finds the Commission's investigation of this incident should be closed.

#### IT IS THEREFORE ORDERED that:

 Basham's payment of Staff's proposed penalty is accepted and resolves the alleged violation that was the subject of the Incident Report.

- Basham's payment of Staff's proposed penalty is not an admission by
   Basham that it willfully violated any provision of KRS Chapter 367 or any administrative regulation promulgated pursuant thereto.
- The Commission's investigation of this incident is closed, and the November
   22, 2019 hearing is canceled.
