ORDER

On August 28, 2019, Burkesville Gas Company, Inc. (Burkesville), filed its Gas Cost Recovery (GCR) rate report with a proposed effective date of September 28, 2019.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Burkesville's report includes revised rates designed to pass on to its customers its expected change in gas costs.

2. Burkesville's report sets out an Expected Gas Cost (EGC) of \$7.0721 per Mcf, which is a decrease of \$.5959 per Mcf from the previous EGC of \$7.6680 per Mcf.

3. Burkesville's report sets out no Refund Adjustment.

4. Burkesville's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$.0791) per Mcf. In calculating its total ACA, Burkesville failed to include the second previous quarter ACA of \$.3300 per Mcf that was approved in Case No. 2019-00073.¹ Correcting this produces a total ACA of (\$.3032) per Mcf, which is a decrease of \$.0601 per Mcf from the previous total ACA of (\$.2431) per Mcf.

5. Burkesville's corrected GCR rate is \$6.7689 per Mcf, which is a decrease of \$.6560 per Mcf from the previous GCR rate of \$7.4249 per Mcf.

6. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after September 28, 2019.

7. Should Burkesville purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Burkesville are denied.


2. The rates set forth in the Appendix to this Order are approved for service rendered by Burkesville on and after September 28, 2019.

3. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
