On September 30, 2019, the Commission received a check in the amount of \$1,000 for payment of Incident No. 21095. A copy of the receipt for that payment is attached to this Order as an Appendix.

The Commission finds that Eaton Asphalt has addressed to its satisfaction the probable violation cited by Staff in the Incident Report. The Commission further finds the Commission's investigation of this incident should be closed.

IT IS THEREFORE ORDERED that:

1. Eaton Asphalt's payment of Staff's proposed penalty is accepted and resolves the alleged violation that was the subject of the Incident Report.

2. Eaton Asphalt's payment of Staff's proposed penalty is not an admission by Eaton Asphalt that it willfully violated any provision of KRS Chapter 367 or any administrative regulation promulgated pursuant thereto.

The Commission's investigation of this incident is closed and the November
22, 2019 hearing is cancelled.

4. This case is closed and removed from the Commission's docket.
