ORDER

On December 11, 2019, the Commission ordered S & B Concrete, LLC, (S & B) to appear at a hearing to be held in this matter on January 24, 2020, at 9 a.m. Eastern Standard Time, in the Richard Raff Hearing Room (Hearing Room 1) of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky 40601, for the purpose of presenting evidence concerning the alleged violation of the Underground Facility Damage Prevention Act described in the Commission's November 14, 2019 Order initiating this proceeding.

On January 6, 2020, the Commission received a money order in the amount of \$250 for payment of Incident No. 31373, and a representative of S & B attended Damage Prevention training at the Commission's offices. A copy of the receipt for that payment and a copy of the sign-in sheet for the training are attached to this Order as an Appendix.

The Commission finds that S & B has addressed to its satisfaction the probable violation cited by Staff in the Incident Report. The Commission further finds the Commission's investigation of this incident should be closed.

IT IS THEREFORE ORDERED that:

- S & B's payment of Staff's proposed penalty and completion of training is accepted and resolves the alleged violation that was the subject of the Incident Report.
- 2. S & B's payment of Staff's proposed penalty is not an admission by S & B that it willfully violated any provision of KRS Chapter 367 or any administrative regulation promulgated pursuant thereto.
- The Commission's investigation of this incident is closed and the January 24, 2020 hearing is canceled.
 - 4. This case is closed and removed from the Commission's docket.
