## ORDER

On December 30, 2019, Sentra Corporation (Sentra) filed its proposed Gas Cost Recovery (GCR) rate report to be effective February 1, 2020.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Sentra's report includes revised rates designed to pass on to its customers its expected change in gas costs.
- 2. Sentra's report sets out an Expected Gas Cost (EGC) of \$3.7413 per Mcf, which is a decrease of \$.3032 per Mcf from its previous EGC of \$4.0445 per Mcf.
  - 3. Sentra's report sets out no supplier Refund Adjustment.
- 4. Sentra's report sets out a current quarter Actual Adjustment (AA) of (\$.1117) per Mcf. Sentra did not use the correct EGC of \$4.9219 approved in Case No. 2019- 00098¹ that was in effect for the months of August, September, and October 2019. Correcting this produces a current quarter AA of (\$.1554) per Mcf. Sentra's corrected total AA is (\$.6714) per Mcf, which is a decrease of \$.8385 per Mcf from its previous total AA of \$.1671 per Mcf.
  - 5. Sentra's report sets out a quarter Balancing Adjustment (BA) of (\$.1382)

per Mcf. Sentra did not include the reconciliation of the expired \$.6831 per Mcf AA and the expired (\$.0072) per Mcf BA previously approved in Case No. 2018-00432<sup>2</sup> in the calculation of its current quarter BA. Sentra's corrected current quarter BA is \$.0661 per Mcf. Correcting this produces a current quarter BA of \$.0661 per Mcf. Sentra's corrected total BA is \$.2115 per Mcf, which is an increase of \$.0733 per Mcf from its previous total BA of \$.1382 per Mcf.

- 6. Sentra's corrected GCR rate is \$3.2814 per Mcf, which is a decrease of \$1.0684 per Mcf from its previous GCR rate of \$4.3498 per Mcf.
- 7. The rate set forth in the Appendix to this Order is fair, just, and reasonable and should be approved for service rendered by Sentra on and after February 1, 2020.
- 8. For the purpose of transpancy and to maintain a record of information for future use the Commission finds that Sentra should continue to submit all invoices it receives, monthly usage reports, and provide the calculations used to justify the NYMEX rate per Dth and the Greystone Adder when it files its future GCR rate reports.

## IT IS THEREFORE ORDERED that:

- 1. The rate proposed by Sentra is denied.
- 2. The rate set forth in the Appendix to this Order is approved for service rendered on and after February 1, 2020.
- 3. Sentra shall submit all information noted in finding paragragh 7 as part of all future GCR filings.
- 4. Within 20 days of the date of entry of this Order, Sentra shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets
