

MINUTES OF THE REGULAR MEETING OF THE BOARD OF WATER COMMISSIONERS OF NORTH MCLEAN COUNTY WATER DISTRICT HELD

NOVEMBER 19, 2018 AT 7:00 P.M. AT THE DISTRICT OFFICE 217 HILL STREET LIVERMORE, KY 42352

The regular meeting of the North McLean County Board of Water Commissioners was held November 19, 2018 at 7:00 P.M., at the District Office in Livermore, Kentucky.

The meeting was called to order by Chairman Keith Ayer, who presided over the meeting.

The minutes of the regular meeting on October 15, 2018 were read. A motion to approve the minutes was made by Commissioner Dale Chandler and seconded by Commissioner Wayne Bell. A vote was taken and motion passed.

Darrell Atherton with Ernie Davis and Sons Mechanical, Inc. requested a four (4) week extension on the East Harmon's Ferry Road Project due to the delay of receiving the pump for the project. The original completion date was December 6, 2018. North McLean County Water District Board discussed the contract with Ernie Davis & Sons Mechanical, Inc. A motion was made by Commissioner Dale Chandler and seconded by Commissioner Carrol Troutman to extend the contract with Ernie Davis and Sons Mechanical, Inc for the East Harmon's Ferry Road Project until December 15, 2018 after that date liquidating damages will apply.

Chairman Keith Aver informed the water board commissioners North McLean County Water District paid \$3,411.97 for electrical services for the new pump station on East Harmon's Ferry Road. The funds were drawn from the North McLean County Water District Construction Account. The Kenergy invoice was submitted via email to GRADD for reimbursement from KIA Funds.

Thairman Keith Ayer informed the board that West Daviess County Water District filed a purchased water rate adjustment to the Kentucky Public Service Commission due to Owensboro Municipal Utilities (OMU) increasing their purchased water rate. The new rate for North McLean County Water District, increased from \$2.41 per 1,000 gallons to \$3.10 per 1,000 gallons effective December 1, 2018. A motion was made by Commissioner Gary Floyd and seconded by Commissioner Wayne Bell for the North McLean County Water District Office staff to begin the process of a purchased water rate adjustment with the Kentucky Public Service Commission.

Maintenance employee Brandon McElwain, discussed a water service line issue with the board. A motion was made by Commissioner Dale Chandler and seconded by Commissioner Gary Floyd that a new policy be in effect that no water service line should go across a water main.

Office Staff Tiffany Sallee informed the board of Chairman Keith Ayer's term ends December 31, 2018. A motion was made by Commissioner Gary Floyd and seconded by Commissioner Wayne Bell to reappoint Keith Ayer for a four (4) year term as North Mclean County Water District's Chairman.

North McLean County Water District Board discussed the employee's of the water district. A motion was made by Commissioner Carrol Troutman and seconded by Commissioner Wayne Bell to increase employee's hourly pay and to include 2019 qualified health premiums limit of \$5,150.00 a year to office employee, Tiffany Sallee in the amount of \$429.16 a month and maintenance worker, Brandon McElwain in the amount of \$332.33 beginning January 1, 2019.

The bills payable were read, approved and ordered paid upon a motion made by Commissioner Carrol Troutman and seconded by Commissioner Wayne Bell. Motion passed with an unanimous vote.

There being no further discussion, upon motion duly made by Commissioner Wayne Bell seconded by Commissioner Dale Chandler and passed without opposition, the meeting adjourned at 8:07 P.M.
