The DSM Steering Committee reviews the DSM Potential Study performed by GDS Associated for each EKPC IRP. That study identifies all potential cost-effective DSM programs. John Farley, DSM consultant, also provides additional insight to DSM program cost-effectiveness evaluations. The DSM Steering Committee, based on their field experience working the membership, helps to identify the need for cost-effective programs. Although no formal process exists to determine need for new DSM programs, participation levels of existing programs are reviewed to assist in determining the need to continue cost-effective programs. Both the DSM Steering Committee and the owner-member CEOs expressed a desire to continue cost-effective residential programs that assist their members having high bills due to energy-inefficient housing.

Salt River Electric uses several methods to promote our DSM programs, such as our website, Facebook, print and radio advertising, and our monthly member newsletter in *Kentucky Living Magazine*. Since the Commission’s order in case 2019-00060 dated February 27, 2019, Salt

River Electric pulled all DSM member communication brochures, information on Facebook, print ads, radio ads and ads in *Kentucky Living* magazine. Our website was updated immediately with the revised DSM programs, found on our website under the “Products and Services” tab, under “rebates” (see below). We are currently in the process of creating new DSM advertising material for the revised programs. Once new materials are created, we will continue to promote the programs through the methods mentioned above.
