### FLEMING-MASON ENERGY COOPERATIVE, INC.

Refer to the response to Staff's Initial Request for Information, Item 6. Explain why you do not offer the low-income energy efficiency demand-side management program known as Community Assistance Resources for Energy Savings as developed and offered by East Kentucky Power Cooperative, Inc.

### **RESPONSE:**

At the time the Community Assistance Resources for Energy Savings (CARES) program was originally introduced, representatives from Fleming-Mason Energy and East Kentucky Power Cooperative, Inc. (EKPC) met with the Executive Director of the Licking Valley Community Action Program that serves most of Fleming-Mason Energy's service area. The program was discussed at length, but it was determined that the local agency did not have any interest in this program; therefore, Fleming-Mason Energy did not file a tariff. Fleming-Mason Energy has not received any subsequent inquiries or interest about the CARES program since, nor does Fleming-Mason Energy have much interaction with the local community action agencies as a whole pertaining to their weatherization programs.
