MOTION FOR DEVIATION FROM 807 KAR 5:001, SECTION

Hardin County Water District No. 1 (“Hardin District”) moves for leave to deviate from 807 KAR 5:001, Section 7 when responding to Commission Staff’s First Request for Information in this proceeding.

In support of its Motion, Hardin District states:

1. On April 23, 2019, Commission Staff issued its First Request for Information in this proceeding.
2. Hardin District has carefully reviewed the request and anticipates that some of the responses will likely be in excess of one thousand pages.
3. 807 KAR 5:001, Section 7 requires a party filing a paper with the Commission to file an original and ten copies in paper medium.
4. Producing the required original and 10 copies in paper medium for the lengthy requests will be very expensive and unduly burdensome. In lieu of producing original and 10 copies of any response that exceeds 100 pages in length, Hardin District proposes to submit the response in portable document format on electronic storage medium (e.g., CD-ROM or flash drive). This alternative method of production of documents will be less burdensome and


expensive on Hardin District and alleviate any administrative burden that the Commission would experience in storing the documents and converting them to an electronic version for posting on its website.

5. This motion is made in good faith and not for purposes of avoiding any requirement imposed by the Commission's Rules of Procedure.

WHEREFORE, Hardin District requests that the Commission permit it to deviate from 807 KAR 5:001, Section 7, and to file in electronic format on electronic storage media any response to Commission Staff's First Request for Information that exceeds 100 pages in length.
