Comes now the Knott County Water & Sewer District (KCW&SD "the Board"), by and thru counsel, and hereby moves the Public Service Commission for a clarification of the Order rendered June 7, 2019.

A question has arisen in interpreting the Order as to the current status of Commissioner Dale Hamilton.

While the Commission does make a finding "...that a vacancy does exist for the position of Water District Commissioner", the Order itself does not make that finding in the legal conclusion.
