Description of Incident Jonathan Hylton was using a backhoe to repair a water line leak for Ina Lee Johnson when he hit and punctured a 3/4-inch plastic service line.

Summary Information 8/24/2018

Full details such as the cause - Mr. Hylton did not call 811 to request a line location prior to excavating. Mrs. Johnson did call Delta at 12:30 p.m. that day to request a line location. Delta employees were in route to the site when the contractor hit and punctured the service line.

Extent of the damage - There were no injuries or property damage attributable to this incident. Delta employees replaced two feet of 3/4-inch plastic service line and installed two permasert couplings.

Cost of the damage - \$173.00

Steps taken to prevent re-occurance - Mr. Hylton and Mrs. Johnson were advised that the law requires anyone that is going to do any type of excavation work to call 811 to request a line location at least two working days prior to starting work. They were also told that when excavation is necessary within the approximate location of the pipeline (18-inches on either side) the law requires hand digging or using non-intrusive means to avoid damage to the pipeline.
