RE: Purchased Water Adjustment-Application Deficiency

Dear Ms. Pinson:

Ledbetter Water District hereby submits documents in response to a filing deficiency in PWA rate Case No. 2019-00196, as noted in a letter from the Public Service Commission dated June 25, 2019.

The letter of deficiency noted that meeting minutes should be signed. Attached is Exhibit 1, a signed copy of the minutes in which the Ledbetter board of commissioners authorized the PWA application for an increase of \$0.15 per thousand gallons. This increase matches the increase requested in the PWA application on Form 1. The board approval of the PWA is documented on page two of the minutes under the heading "C/L Rate case". The minutes state that "We will have to file for a Purchased Water Adjustment and be ready because it will happen quickly. Billy (Billy Downs, system Superintendent) has calculated our increase to be 0.15 per thousand gallons. Terry (Terry Teitloff, commissioner) made a motion for Billy to go ahead and get paperwork started and in motion to get this started for the adjustment (the PWA). Arnie (Arnie Puckett, commissioner) seconds the motion. None were opposed, motion carries."

The letter of deficiency noted that the rates in the meeting minutes do not match those in the wholesale notice. The wholesale notice that was included in Ledbetter's PWA application was the notice that Ledbetter received from Crittenden Livingston Water District, the wholesale supplier. The rates in that initial notice do not match the rates that the PSC approved for Crittenden Livingston. Attached is Exhibit 2, a copy of a notice that Crittenden Livingston sent to Ledbetter after its rates were approved. This notice accurately reflects the rates noted on form 1 of Ledbetter's PWA.

MEETING WAS HELD ON PURSUANT TO NOTICE AND CONSENT BY SAID DISTIRCT, PHILLIP DAE, CHAIRMAN; TERRY TEITLOFF, VICE CHAIRMAN; JAMES SCHADE, SECRETARY-TREASURER; ARNIE PUCKETT, COMMISSIONER; BILL GILLAHAN, COMMISSIONER.

Those Present: Phillip Dae, Arnie Puckett, Bill Gillahan, Terry Teitloff, Paula Malone, Billy Downs, Alan Fox, Ryan Morrow.

Guest: Bill Lipham and his wife, Betty Myrick, Michelle Ladd, Danny Shelby, Willie Lofton, Ricky McIntyre, Janice Riley, Terry Bartlett, Sharon Griggs, Nicholas Frederick.

The meeting was called to order by Phillip Dae at 5:30 P.M.

Betty Myrick is recording this meeting.

Terry can't stay for the whole meeting tonight, so we are going to jump around on the agenda a little bit. We would like to touch on the issues that need a motion or vote first.

Terry made a motion to accept the minutes and financials as written from last month. Bill seconds the motion. All were in favor, none opposed. Motion carries.

### Myrick Tap:

Phillip and Terry said that BJ Myrick has water lines to a trailer on their property that they connected to their residence lines, which is a double tap and against PSC regulations. Phillip asked if it was water and sewer. Yes, it is. Betty said that they realize that they are going to have to pay for a tap, but they are not sure they are going to keep the trailer there. If they do, they will pay for the tap on. She also stated that the inspector came and talked to her husband. Billy asked if the utilities were connected yet, she replied that they were not.

### Minutes-Page 2

### May 23, 2019

Phillip asked her if they were agreeing to pay the tap and she answered yes, if they decide to keep the trailer there. When they connect it, they will pay for it. They want to do their part; it is better to do it that way anyway. Terry told her to tell B.J thank you.

### C/L Rate case:

C/L has applied for the increase, which comes out to 0.25 each, the first two years and 0.26 the third year. The staff has approved it but the PSC has not, yet. We will have to file for a Purchased Water Adjustment and be ready because it will happen quickly. Billy has calculated our increase to be 0.15 per thousand gallons.

Terry made a motion for Billy to go ahead and get paperwork started and in motion to get this started for the adjustment. Arnie seconds the motion. None were opposed, motion carries.

### Ledbetter Residents:

Betty Myrick said she wanted to ask about the loans. KIA is interest free, right? Are we behind on payments? Yes, it is, and we are behind \$67,000.00. We are making \$8,000.00 payments a month to try to catch it up. Who do we make the check to? KIA. KACO is the one we pay interest payments each month. She asked if we were behind on that one. No, we are current on this loan.

She asked who the Water District's lawyer was. David Boswell or Van Simms. Betty said she wanted to say, the public is not upset about the rates, they are upset about the debt. Would the Board consider filing Chapter 11? She has done a lot of research and we can if we decide to.

Arnie said that he had an idea. KIA is interest- free, we can continue to pay that one. KACO is the loan we pay interest on, and a refinanced loan. LWD Board could request the Fiscal Court to pay that loan off, and we repay them at no interest deferring the payments until 2026-2027 when the loan is paid off. He said they probably won't go for interest free, but maybe 2%, which is better than we are getting now. They may say no.
