RE: Powertel/Memphis, Inc. d/b/a T-Mobile
Case No. 2019-00359- Filing Deficiencies

The Commission Staff has reviewed the application in the above case. This filing is rejected for the reasons set forth below.

Filing deficiencies pursuant to:

- (1)** 807 KAR 5:001: Section 14 (2) and (3) – If a corporation, the applicant shall identify in the application the state in which it is incorporated and the date of its incorporation, attest that it is currently in good standing in the state in which it is incorporated, and, if it is not a Kentucky corporation, state whether it is authorized to transact business in Kentucky. Applicant did not identify the date that Powertel/Memphis, Inc. was incorporated. Applicant also did not attest that the Powertel/Memphis, Inc. and Vertical Bridge Development, LLC are in good standing in Delaware, the state in which they were incorporated and organized.
- (2)** 807 KAR 5:063: Section 1(1) (e)- Clear directions from the county seat to the proposed site, including highway numbers or street names, and the telephone number of the preparer of the directions. Although the application’s Exhibit B, Site Development Plant and Survey, Directions to Site, has directions from the county seat to the proposed site, it is not clear who prepared these directions and the directions were not accompanied by a telephone number for the preparer.
- (3)** 807 KAR 5:063 Section 1 (1) (m) - A list of the property owners who received the notice, together with copies of the certified letters sent to listed property owners. A copy of a certified letter addressed to Jason Cox at 3110 Harris Ferry Road, Irvine, KY 40336 was included in the application’s Exhibit J. Exhibit J also included several maps entitled “Abutter’s Map” in the application’s List of Exhibits. The property location in question is marked as H1 in Exhibit J. The name “Jason Cox” does not match the named property owners on the map provided in the application’s Exhibit B with the same Parcel ID of 053-00-00-031.0. The name “Jason Cox” was not listed on the map provided in Exhibit B. An address was not provided for the named property owners in question in Exhibit B, so it is not clear whether the certified letter was sent to the correct address.

You are requested to submit the information necessary to cure the deficiencies within 10 days of the date of this letter.
