**ATTORNEY GENERAL’S REQUEST FOR A HEARING**

Comes now the Attorney General of the Commonwealth of Kentucky (“OAG”), by and through his Office of Rate Intervention, and hereby requests that the Commission set this matter for a hearing. In support of this motion, Counsel states that petitioner has failed to provide complete responses to supplemental data requests.<sup>1</sup> The OAG is unable to conduct a complete review of this case without such information.

Additionally, counsel for OAG requests that the Commission allow him to participate in the hearing in this matter via a telephonic connection. Counsel is unable to attend the hearing in person due to health constraints. The OAG will not be sponsoring any witnesses, and thus will only be cross-examining Salt River’s witnesses.

WHEREFORE, the Attorney General respectfully requests that the Commission grant his request.


