

I was in the property during the month of November performing maintenance and occasionally during the first part of December until it was rented on the twelvth of December. The only water use was to wash out painting equipment and for occasional bathroom use. The meter reading for the first period went from 270 to 271. In the second billed period it went from 271 to 308. The water meter was read by Kentucky American Water Company on 12/26/2019 for verification and it had gone from 308 to 309 for the period of 12/12-12/26/2019. As previously stated there are no leaks in the water lines from the meter to the residence or inside the residence and the property was vacant prior to the new tenant establishing service in their name. I have contacted Kentucky American Water Company by phone on two occasions and online twice to try to resolve this matter. Additonally I also spoke to the Director of Operations Mr. Robert Sherman by phone and in person at Kentucky American Water Company to Mr. Joshua Riley a "Customer Advocate" in order to resolve this matter. Kentucky American Water Company has tested the water meter and informed me that it was functioning properly. They tested it at the property. They did not remove it for testing which would be more conclusive since it is my contention that it malfunctioned when it was in place at the property. They were unable however to retrieve a "data log" from the water meter that would show when the 27,676 gallons were used. It is my understanding that the water meter in question has been removed and replaced by another water meter at the property. Kentucky American Water Company has insisted throughout my attempts to resolve this matter that there is no error in the water meter readings but I believe this to be totally false based on the circumstances described. Since they were unable to retrieve a data log of the use of the 27,676 gallons i contend they were not used and the meter malfunctioned creating a false reading.


