The Commission directs LG&E to the Commission’s March 16, 2020 and March 24, 2020 Orders in Case No. 2020-00085,¹ regarding filings with the Commission.² The Commission expects the original documents to be filed with the Commission within 30 days of the lifting of the current state of emergency. Pursuant to 807 KAR 5:001, Section 20, LG&E is HEREBY ORDERED to satisfy the matters complained of or file a written answer to the complaint within ten days from the date of entry of this Order.
