ATTORNEY GENERAL'S MOTION FOR TWO-DAY EXTENSION WITHIN WHICH TO FILE HIS INITIAL DATA REQUESTS

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("the Attorney General"), and hereby respectfully moves that the Commission grant him a two-day extension within which to file his initial data requests. In support of this motion, the Attorney General states as follows.

By Order dated March 12, 2020, the Commission issued a procedural schedule in the above-styled matter setting Tuesday, March 24, 2020 as the due date for all initial data requests. The Attorney General is in the process of reviewing the voluminous application in this matter, and of retaining an expert consultant. In order to complete these tasks, the Attorney General respectfully requests that the Commission grant him up to Thursday, March 26, 2020 within which to file his initial data requests. The Attorney General is not proposing any further changes in the procedural schedule at this time. If the Attorney General is able to complete any initial data requests prior to March 26, 2020 he will file those into the record as soon as possible, with the goal of completing the filing of all initial data requests no later than March 26, 2020. Counsel for Big Rivers Electric Corporation has advised that he has no objection to this motion.

Therefore, the Attorney General respectfully requests that the Commission grant him a two-day extension within which to file his initial data requests.
