1. The Public Service Commission TO: Matthew Satterwhite, Vice President - Regulatory Services, American Electric Power Co., Inc. ("AEP").
2. You are commanded to appear before the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky 40601.
3. At 9 a.m. Eastern Standard Time.
4. On Tuesday, November 17, 2020.
5. To testify regarding: Kentucky Power Company's application in Case No. 2020-00174, particularly Mr. Satterwhite's knowledge he gained both from his previous position as President and COO of Kentucky Power, and his time spent as Vice President-Regulatory Services. The Commission understands that the Vice President-Regulatory Services has responsibility for AEP's regulatory activities before 11 state regulatory commissions and the Federal Energy Regulatory Commission (FERC). Mr. Satterwhite should be prepared to discuss transmission expense allocation amongst the AEP East


companies generally, as well as transmission cost allocation and recovery related to AEP's and Kentucky Power's (as well as Kentucky Transmission Company's) membership in PJM. Mr. Satterwhite should be further available to discuss those costs as it relates to Kentucky Power's PJM billing line items related to transmission including Network Integration Transmission Services (NITS), and the Load Serving Entity Open Access Transmission Tariff applicable to Kentucky Power. Furthermore, Mr. Satterwhite may be asked about PJM's supplemental transmission planning process as it relates to Kentucky Power's transmission assets, the identification of solutions to needs identified in the PJM Attachment M-3 transmission planning process and the allocation of "solutions" to those needs between Kentucky Power and other AEP affiliates. The Commission may refer to Mr. Satterwhite's testimony in Case No. 2017-00179 regarding the aforementioned subjects, including pages 12-14 of his June 28, 2017 direct testimony; pages 4-10 of his November 3, 2017 rebuttal testimony; pages 2, and 14-15 of his November 30, 2017 settlement testimony; and Mr. Satterwhite's appearance at the hearing in Case No. 2017-00179. Additionally, the Commission may refer Mr. Satterwhite to other publicly available documents, including, but not limited to AEP Kentucky Transmission Company's FERC Form 1, Kentucky Power's FERC Form 1, and the AEP East Companies Transmission Agreement and related documents found at <https://www.aep.com/requiredpostings/FERCRateSchedule>
