ORDER

On June 23, 2020, Warren County Water District (Warren District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

1. Warren District purchases water from the Bowling Green Municipal Utilities (Bowling Green).

2. Bowling Green notified Warren District that its wholesale rates would decrease at the Southside metering point from \$2.6377 per 1,000 gallons to \$2.3168 per 1,000 gallons at the Southside metering point and increase as follows: (1) from \$1.6455 per 1,000 gallons to \$1.7585 per 1,000 gallons at the Cemetery Road metering point; (2) from \$1.7291 per 1,000 gallons to \$1.8547 per 1,000 gallons at the Morgantown Road metering point; and (3) from \$1.7162 per 1,000 gallons to \$1.8481 per 1,000 gallons at the Northside metering point, effective July 1, 2020. Warren District proposes to increase the water rates to its customers effective July 1, 2020, to reflect the increased cost of purchased water from Bowling Green.

3. Warren District proposed a purchased water adjustment factor of \$0.14 per 1,000.

4. During the 12 months ended March 31, 2020, Warren District purchased 36,000 gallons of water from the Southside metering point, 2,032,297,300 gallons of water from the Cemetery Road metering point, 256,149,600 gallons of water from the Morgantown Road metering point, and 951,477,400 gallons of water from the Northside metering point. During the same period, Warren District sold 2,791,735,000 gallons of water. The increase in the cost of purchased water is \$387,310.29, resulting in a purchased water adjustment factor of \$0.14 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.14 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Warren District's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order are fair, just, and reasonable and should be approved for water service rendered by Warren District on and after July 1, 2020.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.14 per 1,000 gallons is approved.

2. The rates proposed by Warren District are approved.

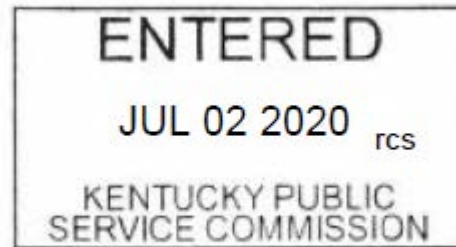
3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Warren District on and after July 1, 2020.

4. Within 20 days of the date of entry of this Order, Warren District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
