ORDER

On October 1, 2020, Bluegrass Water Utility Operating Company, LLC (Bluegrass Water) tendered an application for approval of construction and an adjustment of rates pursuant to 807 KAR 5:001, Section 16. The application was not accepted for filing due to deficiencies identified by the Commission and Commission Staff. Bluegrass Water supplemented its application to cure the deficiencies on November 19, 2020.<sup>1</sup>

On November 23, 2020, The Homestead Home Owners Association, Inc. (Homestead HOA) submitted a motion to intervene. On November 24, 2020, Bluegrass Water submitted a motion for an extension of time of seven days, until December 7, 2020, to respond to Homestead HOA's motion to intervene. Bluegrass Water argues that its response is made difficult by the fact that the seven day response period established by 801 KAR 5:001, Section 5(2), fell primarily over the Thanksgiving holiday and that the extension will not affect any other dates because it is still early in the case.

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that good cause exists for granting an extension of time for Bluegrass Water's response in this case and that the motion should be granted.

IT IS THEREFORE ORDERED THAT:

1. Bluegrass Water's motion for an extension of time is granted.
2. Bluegrass Water shall have up to and including December 7, 2020, to file a response to Homestead HOA's motion to intervene.
